

**SUBJECT: CONFLICT OF INTEREST CODE AMENDMENT – COUNTY ADMINISTRATOR’S
OFFICE**

RECOMMENDATION:

Approve the amended Conflict of Interest Code for the County Administrator’s Office.

DISCUSSION:

The Political Reform Act, Government Code Section 81000 et seq., requires every local government agency to review its Conflict of Interest Code to determine if it is accurate.

The Conflict of Interest Code for the County Administrator’s Office has been reviewed and revised to reflect the current location for filing statements of economic interest and the List of Designated Positions has been updated to reflect the deletion of five positions and the addition of nine positions. This amended Code supersedes any prior Conflict of Interest Code.

FINANCING:

Approval of this recommendation will have no impact on net County costs.

VISION 2026 GOAL:

This action meets the County’s Vision 2026 operating principle of fiscal stewardship.

**CONFLICT OF INTEREST CODE FOR THE
OFFICE OF THE COUNTY OF ALAMEDA COUNTY ADMINISTRATOR**

The Conflict of Interest Code is promulgated under the authority of the Political Reform Act, Government Code Section 81000, et seq., which requires all state and local government agencies to adopt and promulgate conflict of interest codes. Regulation 2, California Code of Regulations, Section 18730, as adopted by the Fair Political Practices Commission contains the terms of a standard conflict of interest code; which may be incorporated by reference and may be amended by the Fair Political Practices Commission after public notice and hearings to conform to amendments in the Political Reform Act.

Therefore, the terms of 2 California Code of Regulations, Section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference and, along with the attached Appendix in which employees are designated and disclosure categories are set forth, constitute the Conflict of Interest Code of the County Administrator's Office.

Employees holding designated positions, other than the County Administrator, shall file their statements of economic interests with the Clerk, Board of Supervisors who will make the statements available for public inspection and reproduction (Gov't. Code section 81008). The original of the County Administrator's statement of economic interest shall be forwarded to the Auditor-Controller's Office and a copy shall be retained by the Auditor-Controller's Office.
