SUBJECT: APPROVE THE CONFLICT OF INTEREST CODE, DISCLOSURE CATEGORIES, AND LIST OF DESIGNATED POSITIONS

Dear Board Members:

RECOMMENDATION:

Approve the Alameda County Probation Department's Disclosure Conflict of Interest Code, Categories, and updated List of Designated Positions to account for position additions and reclassifications.

DISCUSSION/SUMMARY:

The Political Reform Act (Government Code Section 81000, et seq.) requires every local government agency to review its Conflict of Interest Code (Code) biennially to determine if it is accurate or, alternatively, if the Code should be amended.

Changes to the Alameda County Probation Department's (ACPD) existing Code include updating the List of Designated Positions to include additional positions that are required to file a Statement of Economic Interests - Form 700. This amended appendices supersede any prior Conflict of Interest Code from the ACPD. ACPD developed the Code in consultation with County Counsel.

FINANCING:

Approving the recommendation will have no financial impact on the County. No additional appropriations are required and there will be no increase in net County cost.

VISION 2026 GOAL:

The amended Code and List of Designated Positions meets the County's 10X goal pathway of a **Crime Free County** in support of the County's shared vision of **Safe & Livable Communities**.

CONFLICT OF INTEREST CODE FOR PROBATION DEPARTMENT, COUNTY OF ALAMEDA

This Conflict of Interest Code is promulgated under the authority of the Political Reform Act, Government Code Section 81000 et seq., which requires all state and local government agencies to adopt and promulgate a conflict of interest code. Title 2, California Code of Regulations, Section 18730, as adopted by the Fair Political Practices Commission contains the terms of a standard conflict of interest code; which may be incorporated by reference and may be amended by the Fair Political Practices Commission after public notice and hearing to conform to amendments in the Political Reform Act.

Therefore, the terms of 2 California Code of Regulations, Section 18730, and any amendments to it duly adopted by the Fair Political Practices Commission, are hereby incorporated by reference. The Section 18730 terms along with the attached Appendices in which positions are designated and disclosure categories are set forth and defined, constitute the Conflict of Interest Code of the Probation Department.

Designated employees other than the Chief Probation Officer shall file their statements of economic interest with the Filing Officer who will make the Statement available for public inspection and reproduction (Government Code Section 81008). The original statement of the Chief Probation Officer shall be forwarded to the Clerk of the Board of Supervisors and a copy retained by the Filing Officer of the Probation Department.

APPENDIX OF DISCLOSURE CATEGORIES **Disclosure Categories**

CATEGORY 1

All sources of income, interest in real property, investments, and business positions in business entities located in or doing business in Alameda County.

CATEGORY 2

Investments and business positions in business entities and income from sources which provide services, supplies, materials, machinery, or equipment of the type utilized by Alameda County.

CATEGORY 3

Investments and business positions in business entities and income from sources which provide, supply, manufacture of service computer hardware or software of the type utilized by Alameda County.

CATEGORY 4

Investments and business positions in business entities and income from sources which provide services subject to the review and approval of the Probation Department of the County of Alameda and all interests in real property.
